(Received the highest rating of "5 Star" for three consecutive years)

Advance Logistics Fund, Inc. ("ADL") is pleased to announce that it has received the highest rating of "5 Star" in the 2024 GRESB Real Estate Assessment for the third consecutive year.

#### 1. 2024 Evaluation Results

In the 2024 GRESB Real Estate Assessment, ADL received a 5-Star rating, the highest in the five-level GRESB rating system based on the global ranking of overall scores, for the third consecutive year. In addition, for the sixth year in a row, we received the "Green Star" rating, which is granted to operators that are evaluated as excellent in both the "Management Component," which evaluates ESG promotion policies and organizational structure, and the "Performance Component," which evaluates environmental performance and initiatives for tenants at properties held by the company.



#### 2. GRESB Overview

GRESB is the name of the annual benchmark assessment that measures the environmental, social and governance (ESG) considerations of real estate companies and funds and the organization that administers it. GRESB was established in 2009 by a group of major European pension funds, and is unique in that it evaluates the sustainability efforts of real estate companies, REITs, and funds, rather than individual properties.
